

# Wigrams Turn Marina First Month Free Promotion 2026

## Terms and conditions

### 1. Introduction

**1.1** The terms and conditions on this page (the “**Terms**”) apply to our **First month free** promotion (“**Promotion**”). Please also see our Privacy Policy which describes how we use your personal information in connection with the Promotion and your data protection rights.

**1.2** The promoter of the Promotion is Wigrams Turn Waterside & Marina (“**we**”, “**us**”, “**our**” or “**Aquavista**” as applicable). You can find our company and contact details at the end of these Terms.

**1.3** Please read these Terms carefully as, by entering the Promotion (by quoting ‘**First month free**’ when enquiring with us), you will be deemed to have accepted these Terms and agreed to be bound by them. You shall at all times comply with these Terms.

**1.4** We recommend that you print a copy of these Terms for future reference. You can contact us in relation to the Promotion or request a copy of these Terms by writing to us using the contact details at the end of these Terms.

**1.5** Any complaints regarding the Promotion should be sent to us using the contact details at the end of these Terms.

### 2. Eligibility and participation

**2.1** The Promotion is available from 00:00 on 01<sup>st</sup> April 2026 and will end on 23:59 on 31<sup>st</sup> May 2026 (“**Promotion Period**”). Any contracts entered into with Wigrams Turn Waterside & Marina outside of the Promotion Period will not be eligible for the Promotion.

**2.2** To be eligible for the Promotion, the following criteria must apply:

**2.2.1** you must purchase a leisure licence by entering into the applicable contract with Wigrams Turn, with a minimum duration of 12 consecutive months and which must be confirmed on or before on 31<sup>st</sup> May 2026.

**2.2.2** A 10% pre-payment must be paid by on 31<sup>st</sup> May 2026 to secure the contract.

**2.2.3** you must be aged 18 or over.

**2.2.4** you must be a new to Aquavista customer.

**2.3** To enter the Promotion, you must quote ‘**First month free**’ at the time you enter into the Eligible Contract, either online, over the phone or in person.

**2.4** The Promotion cannot be claimed retrospectively, for example, in respect of Eligible Contracts entered into prior to the promotion period, or in any circumstances where you did not quote 'One Month Free' before entering into the Eligible Contract.

**2.5** The Promotion is subject to mooring availability.

**2.6** By entering the Promotion, you promise that all information submitted by you is true, accurate, current and complete. We reserve the right to verify your eligibility to enter the Promotion, during and/or after the Promotion Period (including verifying entrants' identity, age and address).

**2.7** If you end the contract within the first 12 months, you will be required to repay the value of any free month you received.

**2.8** Our decision is final and no correspondence on any matter concerning the Promotion will be entered into.

### **3. The reward**

**3.1** Eligible participants who enter the Promotion will receive the **first month free** on a 12-month leisure mooring contract. The free month is applied at the start of the contract term.

For customers paying annually, the value of the free month will be reflected on the first invoice. For customers paying monthly, the free month will be applied at the beginning of the contract. For customers paying quarterly, the free month will be applied to the first quarterly invoice.

Monthly or quarterly payments will be collected by Direct Debit, and the remaining 11 months of the contract will be charged at the standard mooring rate.

**3.2** Customers will still be required to pay the electric service charge for the first month; however, this cost will be included in, and spread across, the remaining 11 months of the contract.

**3.3** Rewards are non-transferable, non-resaleable and non-negotiable and cannot be refunded, exchanged or amended and have no cash alternative.

**3.4** The Promotion is for personal and consumer use only.

**4.1** We do not accept any responsibility for any damage, loss, injury or disappointment suffered by you as a result of you entering the Promotion or accepting any reward.

**4.2** Nothing in these Terms shall exclude our liability for death or personal injury as a result of our negligence or for fraud or fraudulent misrepresentation or for any other liability that cannot be limited or excluded by applicable law.

## **5. Your personal information**

**5.1** As a result of your participation in the Promotion, we will collect certain personal information relating to you. We will process the information about you in accordance with that policy. ## **7. Governing law and jurisdiction**

**7.1** The Promotion and these Terms are governed by the laws of England and Wales.

**7.2** You can bring legal proceedings in respect of these Terms in the courts of England and Wales. If you live in Scotland you can bring legal proceedings in respect of the Terms in either the Scottish or the English courts.
